4	Heart of Natural Beauty Phase 1 Project (NLHF): Partnership Workshop	
	i. Overview and Context Coralie Barrow provided a presentation on the new Heart of Natural Beauty Phase 1 project, which has been successful in receiving Landscapes Connections funding from National Lottery Heritage Fund. This Phase 1 project is one of a series of Heart of Natural Beauty projects.	
	Heart of Natural Beauty is a transformative opportunity to work with our Partners and engage and connect with the local communities in the 12 sections of the Cornwall National Landscape to enable delivery on nature recovery, people, place and climate.	
	This is a 1 year project, which will include setting up Partnership-led Governance through sub-partnership boards and working with Community Link Officers and local community groups to develop knowledge of local issues and pressures; developing a baseline, gather data and mapping (through GIS StoryMap and 12 interactive dashboard summaries to underpin the development of an integrated spatial management tool that captures local evidence to inform local delivery) and EOI Submission to submit development stage application of the project to NLHF.	

The information gathered in this project will be used to inform the Cornwall National Landscape Management Plan Review.

The StoryMap web based application will build on the State of Report previously produced. It will combine maps with text, images, videos and dashboard data visualisation tool which will be used by the Cornwall National Landscape team when developing and working on projects and also for use by partners, stakeholders and communities so they can tap into useful local data and info.

Next steps: 7th July Partnership meeting and Workshop in-person will be an opportunity for partners to discuss in more detail and focus on the potential 4 themes:

- Healthy people and communities
- Landscape and place
- Climate adaptation and resilience
- Nature recovery and land management

Becky Hughes, Natural England mentioned the Protected Landscapes Target & Outcomes Framework and Coralie confirmed the mapping tool being developed will align to the indicators in the Framework and also will be demonstrating how the project will help meet 30by30 targets.

Julian Gray, SWCP – this fits well with their coastal wildbelt work as one example, how will SWCP be involved and engaged in the 12 Sub Partnership boards as not possible to attend and engage in 12 boards/meetings etc – Coralie added that this governance and ways of working will be discussed to develop appropriate ways of working with partners across all 12 sections and addressing cross-cutting themes etc

Juliette Butler, Historic England – would welcome any joint working on heritage at risk aspects and Coralie confirmed this is part of the project development stage application and is keen to discuss and engage further to benefit heritage at risk etc

Emma Rosenfeld, ERCCIS – would welcome a 1-1 discussion with Coralie to talk further on data development and monitoring

	 Partners provided the following information/links in answer to this question Do you have a climate resilience and adaptation plan (and can you share it)? Cornwall Adaptation Plan is in development and will be able to share once it is sufficiently progressed (Rhys Hobbs is lead officer at Cornwall Council) Cornwall Wildlife Trust in the process of starting to create one - Royal Society of WTs are creating an adaptation planning toolkit at the moment for all wildlife trusts which is due out soon - going to use that as the basis when it's released 	
	Partners will have the opportunity to be involved in working groups to discuss the initial research and co-design the concept and be involved in testing for useability and partners were asked in the Menti questions to indicate if they would be interested in taking part in this.	
	Coralie thanked Partners for their participation in this workshop session. The next Partnership meeting on 7 th July, and further future Partnership meetings will focus on this Heart of Natural Beauty Phase 1 project to allow time and input by Partners.

5	Management Plan Review – Partner engagement	
	Emma reported that from November 2025, the Management Plan Review process will commence, this will be an 18 month process to adoption in May 2027. Alongside the work of the Heart of Natural Beauty Phase 1 Project, Emma will be speaking to partners later in the year to be involved in shaping the revised Management Plan.	
6	Round Table update	
	Partners were asked to briefly update on their current organisational activity and collaborative partnership working within or related to the Cornwall National Landscape.	
	Philippa Hoskin, Cornwall Council – Cornwall and Isles of Scilly Nature Recovery Strategy https://letstalk.cornwall.gov.uk/hub-page/naturerecoverystrategy was published in April 2025, thanks to partners that were involved in the process. A month long 'nature for one and all' media campaign is now being planned and partners are welcome to be involved in sharing social media etc to help 'make some noise for nature'.	
	Funding and resources is awaited from Defra and once this is confirmed then delivery and work on the actions in the Strategy will be taken forward.	
	CC have also released an infographic re Environment Enforcement and Compliance - where to go to report possible concerns re wildlife crime etc <u>Help Protect our Wildlife and Environment Let's Talk Cornwall</u>	

Cornwall and the Isles of Scilly Marine Nature Recovery Framework | Let's Talk Cornwall and Voluntary Marine Conservation public consultation will be taking place in the coming few months. CC is starting initial discussions on the review of the Cornwall Local Plan. Nature Markets for Biodiversity net gain - get in touch with Colin Pringle if want to be involved. Julian Gray, South West Coast Path Assn – been working with World Trails Network and IUCN Trail Corridor definition going to World Congress in Oct, which if successful will give formal recognition nationally of the Coastal Wildbelt. 6th June Stakeholder South West Coast Path Forum event – theme is the Transformative Power of Trails: https://www.eventbrite.co.uk/e/south-west-coast-path-forum-2025tickets-1348378659869?utm-campaign=social&utm-content=attendeeshare&utmmedium=discovery&utm-term=listing&utm-source=cp&aff=ebdsshcopyurl 30th May The Salt Path film launches. Rame Head features prominently in the Film so would welcome speaking with partners on promoting the need for responsible, sustainable access to visitors to Rame Head. King Charles III England Coast Path – celebrating completion of this in Cornwall on 4th June - Natural England have invested significant funding in several improvements which includes the section near Porthallow which has taken the path off the road and onto the coast. Ann Reynolds, Cornwall Council – Heritage at Risk Information Tool (HARIT) is being promoted including with communities - which looks at coastal erosion and water flow based erosion on heritage sites. Historic Environment Record team are starting to look at intangible heritage mapping such as customs, folklore, events. In early June a day is planned at Kresen Kernow for the Protected and Historic Landscapes teams as an opportunity to engage with new Cornwall Councillors. Working on developing further guidance and examples of Cornish Distinctiveness assessments https://letstalk.cornwall.gov.uk/intro distinctiveness The Memorial granite gravestone to commemorate the skeletal remains found on the coast path at Trevone is now in place at Padstow Cemetery – this is a project that the Cornwall National Landscape team were involved in with various events. Sally Weston, WHS - mid way through a year of celebrations by the Devonshire Association of 6 UNESCO designations across Devon – been involved in their discovery days to raise the profile of the WHS designations. This week (w/c 19th May) is the first time the WHS has been involved in work experience placement with students which has been made possible by doing this in collaboration with the Cornwall National Landscape team. Access for All Grant funding from the Cornwall National Landscape - 2 of the WHS areas in 2 of the Cornwall National Landscape sections now has information available on the website to provide access information to visitors so they can be informed and plan ahead if any access needs they have will be met on sites or not before they visit. Environmental Audit EOI is about to be put out.

WHS Management Plan Review and the 20 th Anniversary are both running throughout 2025 so partners will be involved more on this during the year.	
Gwyn Williams, CC Public Health Team – new for 2025 from the UK Health Security Agency is that they have a tick surveillance survey <u>Tick Surveillance Scheme (report a tick)</u> - GOV.UK which aims to promote tick surveilliance, monitoring and detection of non native species - <u>Tick bite risks and prevention of Lyme disease: resources - GOV.UK</u>

19 th June <u>Clean Air Day</u> – promotes sustainable travel with the good journey planner to get to spaces and places more sustainably

Park Yoga – has expanded and there are now 9 places taking place in Cornwall. Improving physical activity and wellbeing but also connection with nature and green spaces

Becky Hughes, Natural England – new NE Management Plan Guidance with Targets and Outcomes Framework and 30by30 – it is hoped the new guidance will be available by November when Cornwall National Landscape Management Plan Review commences, which will be really useful guidance to help with the review process.	
Richard Hollis, FWAG – completed farm visits on Bodmin Moor with help from lain Rowe, Cornwall National Landscape Team and now finalising report write-ups before being sent to the farmers. Agri Environment Scheme SFI closing unexpectedly was disappointing and unknown outcome. Birds of Bodmin Moor event went really well and great feedback from the communities and farmers and landowners. Next event is the Spring Birds of Bodmin Moor event, which has had lots of interest and was fully booked within 24 hours!	
Juliette Butler, Historic England – is the Heritage at Risk Project Officer for Cornwall. Related to Heritage at Risk in the Heart of Natural Beauty project, 27 th June is the final date that revisions and updates can be accepted as the data will be published in November – so please contact juliette.butler@historicengland.org.uk with any updates about any designated heritage assets for the Heritage at Risk register.	
Hugh St Aubyn, Cornwall National Landscape Trust – the Trust has issued 2 grants recently to 2 different applications. Work on revised Business Supporters Scheme is progressing, hoping to launch soon. The Trust is making a funding application to support the Business Supporters Scheme going forward. Jon Stewart, National Trust – new NT Strategy: Our strategy to 2035 National Trust themes of restoring nature, ending unequal access and inspiring people to care about nature, history and beauty. Restoring nature is a very outward focussed target and aligns with the Heart of Natural Beauty Project.	

SW Coastal ambition which is about a wider and wilder coast aligned to the coastal wildbelt and new Nature Recovery Strategy priority for the coast. Cornwall Meadows project – restoring meadows and much of which overlaps with the Cornwall National Landscape – there has been a great deal of interest and enthusiuam. In North Cornwall area, many projects have been delivered with the Cornwall National Landscape team through the Monumental Improvement project and access improvements at Trevose Head. Emma Rosenfeld, ERCCIS - Cornwall Wildlife Trust update: hoping to hear soon from Natural England on the expression of interest for wild beaver release on the Par and Fowey catchments. Audit of youth participation in nature for Cornwall has been undertaken so findings will be shared soon. **ERCCIS update:** successful Biological Recorders Conference held in March. Doing structured monitoring, collecting bird song data, running different surveys, training people to enable them to monitor and ID more things. Emma Rosenfeld recently attended artificial light at night and insect decline training - really interesting to look at the impact of light pollution and maintaining dark spaces, and interested in working with partners more on this. Cornwall ACTION 03: Emma Browning and Coralie Barrow would very much welcome discussions with Emma Rosenfeld and other partners on dark skies, light National pollution and carbon saving advice. The Cornwall National Landscape team is Landscape looking at using capital funding this year to develop a Dark Skies Toolkit. team/ERCCIS/ Inclusion Cornwall are keen to link in on discussions on Dark Skies. other partners Jonathon Jones, Cornwall Agri-food Council - Tregothnan will be at the Royal Cornwall Show this year, showcasing some environmental projects. Research being undertaken on where the 'Fog extends over the Fal' in the mornings during the year and where the moisture can be used on tea plants etc. Aerial photos are being taken, but would welcome discussing with partners more on this and suggested research and monitoring methods. Tregothnan just held their charity weekend, where money is donated to local charities. If anyone has suggestions on who might benefit environmentally from funding from their next charity weekend in April 2026 then let Jonathon know Tremap is mapping Magnolia trees and would welcome linking in with partners on monitoring - more info on the project: Species Sponsors | Tremap 7 Cornwall National Landscape Team Update A briefing paper had been circulated with the agenda papers for partners to read in advance, with an opportunity to ask any questions/further info at the meeting. 1.
